FISCAL YEAR 2022 - 2026 TRANSPORTATION IMPROVEMENT PROGRAM **ADOPTED**



The MPO Board voted unanimously to approve the FY 2022-2026 TIP at their June 11, 2021 meeting. The FY 2022-2026 TIP is based on FDOT's Tentative Work Program snapshot dated 4/5/2021. Prior to adoption the Draft TIP was posted on the MPOS's website for public comments since March 25, 2021. The single public comment received to-date concerned a project mapping error that has been addressed.

Prior to the Board Meeting the Citizens and Technical Advisory Committees reviewed and endorsed the Project Priorities. They are consistent with the 2045 Long Rang Transportation Plan.


TRANSPORTATION DISADVANTAGED SERVICE PLAN — MINOR UPDATE RATIFIED



Every transit agency must develop a Transit Development Plan (TDP) Major Update every five years and an annual update / progress report for all other years. The TDP is a financially constrained, ten-year plan addressing transit and mobility needs, cost and revenue projections, and community transit goals, objectives and policies.
