INFORMATION — IMMOKALEE ROAD CORRIDOR CONGESTION STUDY



Collier County is conducting the Immokalee Road Corridor Congestion Study along Immokalee Road from Livingston Road to Logan Boulevard. The study includes evaluating intersection concepts along the corridor to enhance traffic operations and safety concerns based on current and future travel demands.

The purpose of the project is to identify and recommend potential improvements that would reduce congestion and improve the Level of Service (LOS) along the corridor. The current traffic volumes along the corridor are approaching capacity. Based on anticipated traffic growth, the corridor operations will experience severe delays by 2040 if no improvements are made. The roadway is critical in facilitating movement of local and regional traffic (including truck traffic) in northern Collier County and is one of three east-west connections to I-75 in Collier County.

The study as well as the recommendations are consistent with the Collier MPO 2045 LRTP which identified the Immokalee Road and Livingston Road and Logan Boulevard intersections and the I-75 Interchange for construction in its Cost Feasible Plan. The study is expected to be completed in September of 2021.
