6. Agency Updates

A. FDOT

Ms. Peters: The Draft FY 2023-27 Tentative Work Program in-person public hearing will be held at the FDOT SWAO/SWIFT offices (2nd floor) in Ft Myers on Oct. 27 from 10:00 am 12:00 pm. FDOT will be releasing the revised Tentative Work Program November 4 snapshot.

Mr. Sasser: FDOT provided an update presentation to City of Naples on the 4 Corners area [US 41 and 5th Ave intersection], briefing the city about their progress made on the traffic study, timing, and origin-destination study. FDOT will work to coordinate the study activities with season and provide a report later. How will that fit with requests for US 41 to be rerouted to Airport Road or Goodlette Frank Road?

Ms. Peters: The traffic study will look at it. I can't speak for the engineers, but the intent is not to reroute all the traffic into other areas, although some traffic will naturally filter to Fifth Avenue, Airport Road, and Goodlette-Frank Road.

7. Committee Action

A. Endorse Amendment #2 to the FY 2022-26 Transportation Improvement Program (TIP) & Authorizing Resolution

Mr. Philips: Requested the committee to endorse TIP amendment #2. The amendment includes a new hybrid pedestrian beacon at SR 84 (Davis Blvd) and Rich King Greenway Memorial crossing, funded by stimulus dollars. Second is revising the project schedule to advance ROW and utilities for the widening of SR 29, from New Market to SR 82, also utilizing stimulus funds to advance the project.

Ms. Homiak moved to endorse Amendment #2 to the FY 2022-26 TIP & Authorizing Resolution. Mr. Sasser seconded. Passed unanimously.

A. FY 2023-27 FDOT Tentative Five-year Work Program

Ms. Peters: Presented a summary of the Draft Tentative Work Program. Highlighted the projects using funding provided from the American Rescue Plan Act (ARPA) along with project additions, advancements, deferrals, and projects pushed out of the work program time frame.

Mr. Sasser: On page 5 (of the Work Program), there's money allocated for the toll road [I-75], and it gets lower as years go on?

Ms. Peters: The numbers are sometimes placeholders, unless there's a contract with exact numbers, the funding changes so that's just how FDOT does it.

Mr. Gelfand: Some localities are going with unmanned toll booth, what's our plan?

Ms. Peters: It's in discussion. Lee County made that move. Will find out.

Mr. Gelfand: Florida accepts Easy Pass and Sun Pass to make it easier, the next natural step is automatic on everything.

EXECUTIVE SUMMARY COMMITTEE ACTION ITEM 7A

Endorse Florida Department of Transportation (FDOT) Vision Zero Safety Performance Targets for Calendar Year 2022

OBJECTIVE: For the Committee to endorse the FDOT Safety Performance Targets for calendar year (CY) 2022.

<u>CONSIDERATIONS</u>: Safety Targets are the only federal Transportation Performance Measures (TPM) that must be adopted annually. FDOT establishes the state's safety targets in the Highway Safety Improvement Plan. FDOT has notified the MPOs that it will maintain the Department's Vision Zero safety performance target for CY 2022. MPOs have the option to either adopt the Statewide safety targets or establish their own quantifiable safety targets.

The Collier MPO has traditionally elected to adopt the FDOT statewide targets. Performance metrics for the years 2012-2019 and the FDOT CY 2022 Vision Zero targets are shown in the following table.

<u>OBJECTIVE:</u> Committee endorsement of Amendment #3 to the FY 2022-2026 Collier MPO Transportation Improvement Program (TIP), and authorizing resolution.

CONSIDERATIONS: The Florida Department of Transportation (FDOT) has requested the Collier MPO to amend its FY 2022-2026 TIP to add the following projects:

- 435210-1: Notice of Grant Award: Add new Federal Transit Administration (FTA) 5310 capital assistance project and funding to FY 2022 to purchase three (3) buses.
- 448810-1: Project Description: Add a new FTA 5310 capital assistance project and funding to FY 2022 to purchase radios and tablets.
- **450306-1:** Project Description: Add a new FTA 5339 capital assistance project and funding to FY 2022. This project makes improvements at 9 bus stops to bring the locations into Americans with Disability Act (ADA) compliance.
- 449143-1: Project Description: Add a new project to FY 2022 to start the Preliminary Engineering (PE) phase for a wildlife crossing on SR 29 north of the Panther Refuge. Project is funded with American Rescue Plan Act (ARPA) funds.

MPO RESOLUTION #2021-13 A RESOLUTION OF THE COLLIER METROPOLITAN PLANNING ORGANIZATION APPROVING AMENDMENT #3 TO THE FY 2021/22- 2025/26 TRANSPORTATION IMPROVEMENT PROGRAM

WHEREAS, State and federal statutes, rules and regulations require that each designated Metropolitan Planning Organization develop and adopt a Transportation Improvement Program ("TIP") and set forth the procedures for doing so; and

WHEREAS, the Collier Metropolitan Planning Organization's (the "MPO") TIP may require amending as authorized and required by 23 C.F.R. Part 450 Sections 326, 328, 330, 332 and 334, and by F.S. § 339.175(6), (8) and (13); and

WHEREAS, the FDOT requested the Collier MPO to amend its FY 2021/22-2025/26 TIP to add Federal Project Number (FPN) 435210-1 Capital Assistance funding to purchase buses; FPN 448810-1 FTA 5310 Capital Assistance funding to purchase radios and tablets; FPN 450306-1 FTA 5339 Capital Assistance funding for ADA improvements at bus stops; and FPN 449143-1 in ARPA funding in FY 2022 for a wildlife crossing on SR 29, as shown in Exhibit 1; and

WHEREAS, FDOT has submitted two letters to the MPO stating that the amendments are necessary to include in the MPO's TIP to ensure consistency with FDOT's Work Program, as shown in Exhibit 2; and

WHEREAS, the MPO announced the TIP Amendment on its website, distributed it via e-mail to various list-serves, and followed all of the steps of its Public Participation Plan through the expiration of the public comment period, which terminated with the MPO's meeting on December 10, 2021; and

WHEREAS, the MPO has reviewed the proposed TIP Amendment for those projects and determined that it is consistent with the MPO's adopted plans and policies; and

WHEREAS, in accordance with all required State and federal procedures, rules and regulations, including but not limited to the FDOT's MPO Administrative Manual, the TIP Amendment must be accompanied by an endorsement indicating official MPO approval.

THEREFORE, BE IT RESOLVED by the Collier Metropolitan Planning Organization that:

- 1. The FY 2021/22 2025/26 Transportation Improvement Program Amendment #3 set forth in Exhibits 1 and 2 is hereby adopted.

The undersigned accepts the above-described award and:

- b) The Subrecipient agrees to use and maintain the grant awarded equipment in accordance with the federal and state program requirements, and for the services described, in its approved application.
- c) The Subrecipient agrees to comply with all applicable civil rights statutes and implementing regulations.
- d) The Subrecipient agrees to contact the FDOT Contractor, Lazara Stinnette, at the Center for Urban Transportation Research (CUTR), Florida Transit Research Inspection and Procurement Services (TRIPS) at 813-974-0695 to arrange purchase of the above items. This purchase will follow the Department's Guidelines for Acquiring Vehicles and Equipment.
- e) The Subrecipient must do the following **PRIOR** to the purchase of **EQUIPMENT**:
 - Follow <u>FDOT Procurement Guidance for Transit Agencies</u> manual, as amended, and complete the appropriate Third-Party Checklist in accordance with the procurement threshold, as outlined in the Introduction, and submit to your FDOT Transit Projects Coordinator for review. Once the Agency has received applicable FDOT Third-Party Procurement concurrence from their FDOT Transit Projects Coordinator, they may purchase equipment.
 - For reimbursement from the Department, provide a Reimbursement Invoice, an Agency Invoice, signed Third-Party Procurement Checklist and proof of purchase and payment (such as merchant receipt) to your FDOT Transit Projects Coordinator.

- 3) All concurrences and documentation noted in Items e) 1 and 2 must be completed and submitted to your FDOT Transit Projects Coordinator on or before April 15th. The FDOT Transit Projects Coordinator will then forward approval to Lazara with CUTR to request reimbursement. If this deadline is not met, funds will be moved into future fiscal years.
- f) The Subrecipient MUST request purchase of the VEHICLES on or before April 15, 2022.
- g) The Subrecipient agrees to submit the local matching funds when requested to do so.
- h) The Subrecipient, if it is not a Community Transportation Coordinator (CTC), agrees to submit its Annual Operating Report (AOR) data to the CTC as requested.
- i) The Subrecipient will forward a copy of its maintenance plan as outlined in their Transportation Operating Plan (TOP) or System Safety Program Plan (SSPP) to Ms. Dale Hanson within 30 days of receiving the vehicle, if you have not already done so.
- j) The Subrecipient is required to insure the vehicles. The Department shall be named as "certificate holder" on the insurance policy throughout the time period the Department is the only lien holder. The Subrecipient shall be required to submit proof of insurance showing minimum coverage and the Department listed as "certificate holder" within 30 days of receiving the vehicle and provide proof of insurance yearly.

SPECIAL CONSIDERATIONS:

E-Verify - Vendors/Contractors:

- 1. Shall utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of all new employees hired by the Vendor/Contractor during the term of the contract; and
- 2. Shall expressly require any subcontractors performing work or providing services pursuant to the state contract to likewise utilize the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of all new employees hired by the subcontractor during the contract term.
