#### 6.A. FDOT

**Secretary Nandam:** Normally when presenting the work program there's a video and a conversation, this year there's a special treat video highlighting what we do in communities and the partnerships we have built with our customers. I wanted to highlight a couple of projects related to the work program. The State Road (SR) 951 and I-75 interchange advancement was a huge win for us (district and Collier County). I highlighted the great partnership we have with Collier County at our Transportation Commission Performance Review. Our great partnership with Collier County also helped us to leverage funding to advance the SR 29 widening project (from SR 82 to New Market) using the same infrastructure funding.

**Ms. Peters**: Another Tentative Work Program snapshot was done on November 4. Quick update on SR 29 at Westclox St. [in Immokalee]; this is one of the highest incident locations in the county. Currently there is a blinking light at the intersection. FDOT has purchased traffic signal equipment for that intersection, and Collier County will install the traffic signal. FDOT is waiting on some parts needed for installation that are delayed due to supply chain issues. Once the parts are received in December, Collier County will install the equipment. Estimated completion is March or April 2022.

The first project added is a new hybrid pedestrian beacon at SR 84 (Davis Blvd) and Rich King Greenway Memorial crossing, funded by stimulus dollars. Second is revising the project schedule to advance ROW and utilities to widen SR 29, from New Market to SR 82, this project also utilizes stimulus funds to advance.

# 9.B. Approval of a Work Order for Tindale Oliver Associates to update the Congestion Management Process

**Ms. Otero:** Presented the Executive Summary. This is a Work Order to update the Congestion Management Process. The Congestion Management Committee reviewed the scope and asked to include locations in the scope, which have been included.

Commissioner Taylor: What is the fiscal year?

**Ms. Otero:** We run on the State's Fiscal Year (FY), July 1 to June 30.

**Commissioner Taylor:** So, 2021 would be done?

**Ms. Otero:** Because the Unified Planning Work Program and grant run on a two year cycle, we can still draw down funding from 2021 funding as long as the task is identified in both years.

Commissioner Taylor moved to approve Work Order for Tindale Oliver Associates to update the Congestion Management Process. Commissioner Solis seconded. Passed unanimously.

## 10. PRESENTATIONS (MAY REQUIRE BOARD ACTION)

## 10.A. FDOT Draft Tentative Work Program FY 2023-2027

**Ms. McLaughlin:** The Draft Tentative Work Program and Summary of Changes are in the packet. In accordance with the Long-Range Transportation Plan (LRTP) and MPO Board policy, the focus is on congestion management and using SU funding from the Transportation Improvement Program, for FY 27.

Secretary Nandam: This work program has a lot of great wins for all MPOs. The only challenge building this work program is in FY 25-26, the resurfacing program doubled, last year resurfacing was about 200 miles, this year the demand doubled, so there's about 400 lane miles. This means the amount of money allocated towards resurfacing doubled, so there were some minor changes that had to happen to accommodate resurfacing needs. FDOT is statutorily required to do preservation projects first before capacity. One project that moved into a candidate status is the widening of SR 951 south of US 41. I want to affirm we will actively look for opportunities, like with the federal infrastructure bill, to get this project back into the work program. But that's the only change due to resurfacing. The federal infrastructure bill was passed, this is an opportunity for FDOT to work with local communities to identify priorities. There (are) formula allocations to the state that go to MPOs and discretionary programs in the act, as soon as (the)

president signs (the bill) they'll [Federal Highway Administration] will put out criteria and direction on how to leverage the discretionary funding. We'll be working with communities to build project lists. Those projects that could qualify—that went through the correct process—we'll work on grant applications with local communities to submit grant applications for discretionary funding either by the local communities with FDOT support, or FDOT will submit the discretionary grant applications with local support. We need to be aggressive to ensure we get the right investments by working together.

**Commissioner Taylor:** Understand the delay in widening, but will you mow the grass and get rid of invasives, this widening was imminent so there was an understandable neglect, but it needs to be addressed.

**Secretary Nandam:** Got notification through County staff regarding the conditions on US 41 and 951 and the canals, we talked with contractor to make sure they do it, Ferrovial is a great contractor.

**Commissioner LoCastro:** Last two weeks they killed a Brazilian Pepper [tree] then it sat there dead. We had a meeting, they were out there mowing two solid days, doing the stretch going to Marco Island, and picking up trash. Even if they are light on staff the trash needs to be picked up.

**Secretary Nandam:** DBI, the asset management contractor, gave us notification that they are closing doors on Friday. They had at least 25 facilities with the department. FDOT brought in Ferrovial who works with Collier County and are working with the DBI subcontractor to get things done. There is a lag to get things done, please be patient, good thing is, now FDOT is in the process of hiring new contractor. The next 6 months might be rough but we're doing everything we can to take care of it. It's an interesting challenge when we depend on contractors and a big contractor goes belly up. We have notified the new contractor, but it takes some time, they will take over maintenance once things are in place.

**Ms. Peters:** That video speaks to collaborative nature of FDOT and our public and leaders. Thanks to local partners, MPO and Growth Management staff. The Draft Tentative Work Program includes a new year: FY 27. The first (project) priority: 91st Ave. N, 5-ft sidewalk on the south side of the road is fully funded for design and construction in FY 25 and 27. Second and third priorities from the congestion management list were also funded, this includes the Vanderbilt Beach Road corridor study from Airport Road to Livingston Road, and the ITS fiberoptic and FPL power infrastructure at 18 locations, both are fully funded for FY 26. We were also able to fund construction phases on previously programmed projects, including the additional left turn lane from US 41 to Golden Gate Parkway, and the City of Naples Mooring roundabout. Finally, we are pleased to award a safe routes to school grant to Collier County for the Lavern Gaynor Elementary School, with design starting in FY 25 and construction in FY 27, and a new Small County Outreach Program (SCOP) resurfacing project in Immokalee. The next video shows how FDOT works hard to improve communities' everyday living.
