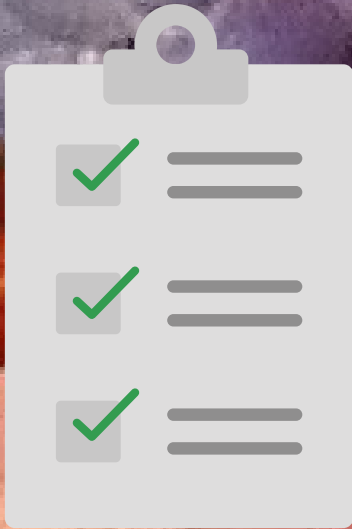

## COMMITTEE VACANCIES

Do you want to be a part of the decision process for the Collier MPO? Join one of the MPO's advisory committees! There are 5 open vacancies.

### Bicycle Pedestrian Advisory Committee (BPAC)

The BPAC is comprised of twelve at-large voting members who provide citizen input into the process of deliberation on bicycle and pedestrian-related issues within the community and make recommendations to the MPO Board on bike/ped policies, projects and programs. The BPAC utilizes the MPO's Bicycle & Pedestrian Master Plan as the overall planning document for BPAC recommendations on bike/ped projects.

### Citizens Advisory Committee (CAC)

The CAC is comprised of citizens representing geographic areas, as well as citizens representing the disabled and minorities. These individuals make recommendations to the MPO Board from the public's perspective on proposed Long Range Transportation Plans, individual projects, priorities for state and federal funding, and other transportation issues.

# UPDATED SUNTRAIL ALIGNMENT GOING TO BOARD FOR APPROVAL IN MAY

The Bicycle and Pedestrian Advisory Committee has endorsed an updated Shared Use Non-Motorized (SUN) Trail alignment proposed by the Naples Pathways Coalition based on its Paradise Coast Trail Vision Feasibility Study which is still underway.

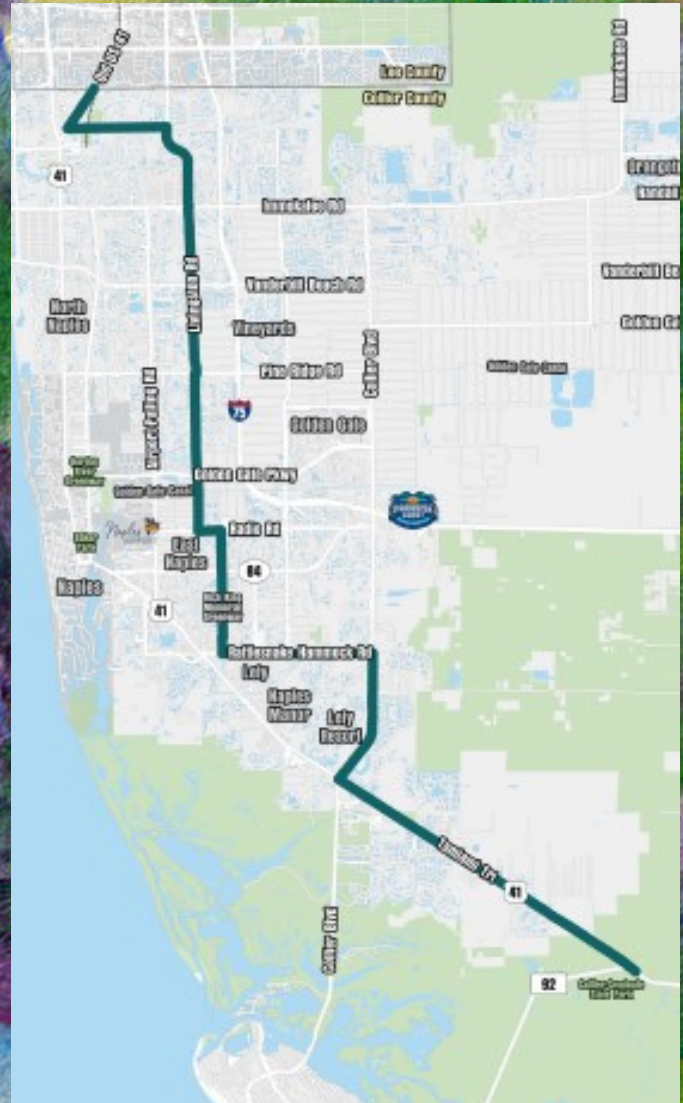
The updated alignment is going to the Technical and Citizens Advisory Committees for endorsement on April 25th, then to the MPO Board on May 13th.

The MPO must submit GIS shapefiles of the new alignment to the Department of Environmental Protection - Office of Greenways and Trails by May 31st in order to be incorporated into the Florida Greenways and Trail System Plan and Priority Maps.
