FDOT and FHP Urge Driver Awareness After Maintenance Crew is Hit on I-75 in Collier County

An FDOT maintenance crew was hit on I-75 South near the Immokalee Road exit while picking up litter along the Interstate. [*Click here for the news story, as reported by WINK News*.] FDOT has been working to clean up increasing debris on I-75 between Naples and Tampa. *Florida's Move-Over Law* provides that if law enforcement, first responders, or any kind of working crew are stopped on the side of the road, drivers have to move over a lane. If they can't, they have to slow down to 20 miles per hour under the speed limit.

Drivers are also urged to secure loose items and debris in their vehicles while driving on the Interstate.

Collier MPO Awarded Safe Streets for All (SS4A) Action Plan Grant

The purpose of SS4A grants is to improve roadway safety by significantly reducing or eliminating roadway fatalities and serious injuries through Safety Action Plan development and implementation.

Collier MPO was recently awarded an SS4A Action Plan Grant! Action Plan Grants are used to develop a comprehensive Safety Action Plan for the community. Upon approval of a developed Safety Action Plan, member governments become eligible to submit applications for project specific implementation grants.
