### 1. Call to Order

## 3. Approval of the Agenda

Mr. Bonness moved to approve the agenda. Seconded by Mr. Musico. Carried unanimously.

## 4. **Approval of the Minutes**

### 4.A. Approval of the January 16, 2024 Meeting Minutes

**Ms. Sproviero** noted that on page 6, her name and title was entered as "Mr. Sproviero" rather than Ms. Sproviero. Staff confirmed the minutes would be revised to reflect this correction.

**Ms. Sproviero** moved to approve a revised version of the January 16, 2024 minutes. Seconded by **Mr. Musico.** Carried unanimously.

## 5. Open to the Public for Comment on Items Not on the Agenda

**Mr. Despard** said that he lives in East Naples and rides his bike in Sugden Park around Lake Avalon. He said that it was repaved but about 3-4 inches on the sides of the trail were not filled, and he believes it is dangerous. He reached out to Collier County Parks & Recreation but has not heard a response. He also wanted to mention that he thought the beautification project recently completed on Thomasson was very good, but on Danford St on the way to Bayview Park there are several driveways that cut into the shoulder/bike lane and are all at different elevations and made with materials, and that it seems dangerous for bicyclists and pedestrians.

Ms. Halman recommended to Mr. Despard to call 311 about the issue as well.

### 6. Agency Updates

### A. FDOT:

**Ms. Merkle** wanted to let the committee know that FDOT's Statewide Non-Motorized Traffic Monitoring Program (NMTMP) is in place, with the first Count Station having been installed December 4, 2023 at Gordon River Greenway at North Rd. It has both infrared and an inductive loop. The total December count was 19,988 with 13,229 being pedestrians and 6,759 bicyclists. Another Count Station is planned to be installed at The Rich King Memorial Greenway at S.R. 84. **Ms. Merkle** mentioned that more funding for NMTMP was anticipated and invited Committee members to submit proposed Count Station locations. She also suggested members go to the <u>Florida Non-Motorized Traffic Monitoring (fdot.gov)</u> to stay up-to-date on installations and to make location suggestions and inquiries.

**Mr. Matonti** asked **Ms. Merkle** if she was aware of any FDOT studies occurring for U.S. 41 and 5<sup>th</sup> Avenue in Naples regarding bicycle and pedestrian facility improvements.

Ms. Merkle said she would investigate and provide Mr. Matonti with an update.

#### B. MPO:

**Ms. McLaughlin** explained that the Collier MPO Executive Director candidate had withdrawn her application and that Ms. McLaughlin had extended her contract to continue in the role for another year.

**Mr. Kingston** announced that Capital Consulting Solutions was scheduled to attend the BPAC meeting in May to present their deliverables for the Collier MPO Bicycle Pedestrian Master Plan (BPMP).

### 7. Committee Action

# A. Discuss MPO Board Request for Committee Recommendations on Safely Accommodating eBikes

**Mr. Matonti** mentioned that in 2023, BPAC suggested an Amendment to an Ordinance the County was considering which would restrict eBikes on sidewalks, which was to focus on public education rather than regulation. The Ordinance did not pass, but the conversation regarding how to manage eBikes in the Collier region continues.

At the February 2024 Board meeting, Council Member Greg Folley raised safety concerns regarding e-bikes on shared use paths on Marco Island. MPO Chair, Commissioner William McDaniel, requested that BPAC discuss the eBike issue and make recommendations to the Board. The item is being presented to BPAC for Committee discussion and the notation of any new thoughts or findings that may have been obtained since 2023.

**Mr. Musico** said that the Marco Island Bike Paths Volunteer Committee conducted a public survey asking for public opinion about eBikes at a Marco Island farmer's market. Opinions included concerns for safety, the need for eBike driver's education, and restrictions or speed limits on shared use paths.

A group discussion followed, and it was agreed that eBikes travel at unsafe speeds on sidewalks and shared use paths, and that the Committee's recommendation should be simple and focused.

**Mr. Bonness** commented that the issue shows that more bike lanes are needed to accommodate eBikes.

**Ms. Avola Brown** made a public comment saying that the current eBike issue shows the need for wider multi-use paths in the Collier region. She had seen 12-ft wide multi-use paths in other parts of the state that seemed to accommodate various micromobility vehicles at various speeds, as well as pedestrians, without issue. She noted the dangers of riding in bike lanes, citing several accidents due to traffic congestion and distracted drivers. She agreed with the need for more education for eBike riders.

**Mr. Musico** responded to Ms. Avola Brown by citing the lack of space available for 12-ft multiuse paths in the Collier region and suggested that a 10-mile per hour speed limit, unless otherwise posted,

might be the best possible solution given the lack of available space for wide paths and without restricting sidewalk use to eBikes who are riding under 10 mph .

**Mr. Bonness** disagreed that bike lanes are not safe for bicyclists and eBikes, saying that because of the location of bike lanes, drivers have better view of riders in bike lanes and that the data from the first 5 years bike lanes were introduced in Florida, there were more fatalities on sidewalks.

*Mr. Musico* moved to make a recommendation to the MPO Board for a 10-mile an hour speed limit for all vehicles on sidewalks and shared-use paths unless otherwise posted. Seconded by *Ms. Sproviero*. Carried unanimously.

A group discussion followed regarding various road, bike lane, and sidewalk safety issues for bicyclists and pedestrians, and the need to consider regional infrastructure modifications to retrofit existing roadways to accommodate eBikes and other moderate speed capable micromobility vehicles. The question if the County had a Bicycle Pedestrian Coordinator on staff was raised.

**Ms.** Fendrick made a motion to make a secondary recommendation to the MPO Board to take a broader look at the current infrastructure to better accommodate eBikes. Seconded by **Mr. Musico.** Carried unanimously.

Ms. Scott responded to the question if the County had a Bicycle Pedestrian Coordinator on staff by explaining that in the past a Collier MPO staff member fulfilled the position by working with FDOT, as FDOT was facilitating Bicycle and Pedestrian coordination for the state. At one time, Ms. Scott served as a Bicycle and Pedestrian project manager for the County and worked on many safety initiatives. Since that time, the Bicycle and Pedestrian project manager role has morphed into a more specified role of getting facilities into the construction phase. Ms. Scott explained that the current project manager is solely implementing sidewalk and bike lane projects. She cited that there are so many projects, her sidewalk reserve fund has gone from \$6 million to \$150k. She said that there are many projects in process, many of which have been funded through Collier MPO, and that there is a focus is on infrastructure.

### 8. Reports & Presentations (May Require Committee Action)

### A. Update on Seminole Gulf Railway and the Bonita-Estero Trail Project

**Mr. Hattaway** explained that the Bonita-Estero Rail-Trail (BERT) corridor is nearly 15 miles long from Estero Blvd to Wiggins Pass Rd. TPL, has the property under contract for \$82 million, and has until March 2026 to purchase the property. TPL is seeking local support for the project to aid its fundraising activities and planned to present to the MPO Board in April, with a request to place it on the MPO project priority list.

**Mr. Hattaway** provided presentation on the Bonita-Estero Rail-Trail, which included detailed information about the project. This information and resources to learn more can be viewed in the 8.A. attachment in the March 19, 2024 BPAC Agenda.

- **Mr. Musico** noted his concern about prioritizing the Bonita-Estero Rail-Trail over the Collier to Polk Trail.
- **Ms.** McLaughlin explained that the projects aren't in competition for funding and that both projects are an important part of the same system being developed.
- **Mr. Komanecky** expressed his support of the project, citing the positive effects of similar projects he had seen in other regions.
- **Ms.** Huff moved to recommend Seminole Gulf Railway and the Bonita-Estero Trail Project as a priority. Seconded by **Mr. Komanecky.** Carried unanimously.

### **B.** Update on Call for Projects

- **Ms. McLaughlin** said she was aware of applications from members for projects in Everglades City and Marco Island, and that Ms. Scott was in attendance to address the Committee regarding the status of Collier County. **Ms. McLaughlin** mentioned that she was aware of major cost increases for projects in Collier County, and that it might be advantageous for the Committee to consider the prospective robust regional network currently in progress when working through the Bicycle Pedestrian Master Plan (BPMP), suggesting that the most effective path might be to focus on accomplishing that vision.
- **Ms. Scott** said she expressed concern upon seeing the recent notification for Call for Projects because the many projects that were programmed and funded as priorities almost ten years ago are now in progress for the next five years. She said the project cost estimates are showing a 100% increase over programmed funds. With the help of the MPO, the County has been able to offset some costs. **Ms. Scott** said she is working with the Board of County Commissioners to evaluate the additional funding needed to complete the projects and would be remiss to add more projects when there is a deficit.
- **Ms. Huff** asked about the County's schedule for resurfacing, referring to the path from Everglades City to Chokoloskee.
- **Ms. Scott** said the path was not currently scheduled for resurfacing, but invited Ms. Huff to email her with more details
- **Mr. Matonti** asked how the County's funding status might affect the Seminole Gulf Railway and the Bonita-Estero Trail Project.
- **Ms. Scott** said there may be different funding strategies available because of the preserved lands on either side of the corridor, there could be a possibility of collaborating with Conservation Collier.

This item was presented for review and comment only.

#### C. Update on Collier to Polk Trail

Ms. McLaughlin explained that the item was being presented for the Committee to receive an update on the Collier to Polk Regional Trail and provided a presentation. She said that the MPO received an announcement from the Office of Greenways and Trails (OGT) that the Florida Greenways and Trails Council (FGTC) is meeting on March 27-28, 2024 in Winter Haven, FL to reprioritize regional trails. Collier MPO had been asked to represent the three MPOs affected by the trail alignment, which include Heartland and Polk TPOs, and was collaborating with the other organizations on a presentation for the meeting. FDOT was preparing the Collier to Polk Master Plan. She said that the Council was meeting to vote on the re-ranking of regional trail projects due to the recent expansion of the State's SUN Trail system.

This item was presented for review and comment only.

## 9. Member Comments

**Ms. Huff** announced that Collier County was working on a road diet in Everglades City from the circle to Everglades National Park and thanked all who assisted in implementing the project.







1. What is your primary mode of transportation for daily commuting? 39 responses




2. Have you considered using alternative modes of transportation, such as bicycles, walking, or public transit?






3. What challenges or obstacles do you face in using your preferred mode of transportation? <sup>39 responses</sup>



4. Are there specific improvements or additions to transportation infrastructure that would encourage you to switch to a different mode of transportation?




5. What role do safety and security play in your decision to choose a particular mode of transportation?


1. How would you rate the current condition of sidewalks and pedestrian pathways in your community?






2. Are there specific areas in your community where you believe improvements to sidewalks or pedestrian pathways are needed?




4. Are there areas in your community where you feel there is a lack of adequate lighting, making walking or cycling unsafe during certain times of the day?






## Priority Areas

1. In your opinion, what are the priority areas in your community that should be focused on for improving pedestrian and bicycle infrastructure?


















1. What are your aspirations for the future development of pedestrian and bicycle infrastructure in your community?






2. Are there specific sustainability goals you would like to see incorporated into future transportation planning, such as reducing carbon emissions or promoting eco-friendly modes of travel?






1. Are you a full-time or part-time resident of Collier County? 135 responses



2. How often do you walk or bike around Collier County? 135 responses






# 5. How important is it for Collier County to make walking and biking safer and easier? 135 responses



## 6. What would make you want to walk or bike more instead of driving?




# 7. How much time do you spend walking or biking on an average weekday? 135 responses







# 8. How do you think more people walking and biking would affect Collier County? 135 responses

# Please share any other thoughts or comments related to the Bicycle Pedestrian Master Plan for Collier County:

- Wider sidewalks with dedicated bike lanes. Some kind of physical barrier between bike and pedestrian lanes and car lanes.
- Bicyclists should minimally share roads with cars. Too many drivers driving fast and aggressively
  makes it very dangerous for all. Spend money on better law enforcement catching dangerous
  drivers. Some of the answers to the questions above were poor options and did not reflect my
  opinions.
- Have bike lanes Completely separated from traffic. That is have a curb/barrier between bikes and cars. The pedestrian injury/fatality stats here are bad.
- To give people a true alternative to driving, we need a connected grid of separated bike paths.
- Car traffic is much worse on school days than on weekdays where CCPS is on vacation. Effort should be put towards increasing biking and walking to school. Keep track of who arrives by bike/walking and give out prizes for anyone who bikes/walks 80% or more of the school year? (Similar to attendance prizes)
- Whether you'd let your kindergartner ride their bike there should be the test for bike infrastructure. Bike lanes and sidewalks inches from 55mph traffic doesn't cut it.
- The part of the Immokalee Rd bike path that floods should be elevated, with drainage underneath. It's crazy that for most of Season, the path is unusable."
- WE MUST HAVE BARRIER PROTECTED BIKE LANES. Paint won't protect me. I will ride in the driving lane unless there's a barrier.
- More POLICE TICKETING cars that blow through stop signs.
- Protected multi use paths would be best and get the most use. With the growth in Collier County, we need to find more ways to get cars off the roads.
- I bike in Pelican Bay and traffic is very fast, driver do not stop at crossings.
- Riding on roads with 50 speed limits 41 l Vanderbilt is not a safe option yet collier considers these bike lanes.
- Contractors park trucks in bike lanes, gulf shore etc
- The off-road lane on Vanderbilt drive is great
- Have you looked at the Pinellas bike way in St Pete, it is super. "
- Bicycles should not be on the same path as pedestrians. Especially electric or motorized bikes.
- The air quality here in the past 2 years has gotten so gross. I can smell carbon monoxide just about every day during the season. Since Collier County is about tourism and seasonal bringing people here, why wouldn't we want to make it a place where they choose to be safe on their bikes and stop polluting the area in cars for short trips? Then also make it healthy for all of us here round. With all the development going on and the cutting back on open space, the last thing we want to be doing is polluting the air more because flash forward 5 or 10 years and this place is going to be an unhealthy place to be.
- This was a poorly designed questionnaire. It assumes that one's opinion of the needs of walkers and bikers is the same, when in fact they may not be. Questions could be answered differently if biking and walking needs were addressed separately.



- Motorized types of transport should NOT be allowed on sidewalks. They move too fast and do not stop at intersections. They are a hazard to pedestrians and drivers.
- More education is needed for out-of-state visitors. Flashing crosswalks are a big help, thank you.
- What happened to the MASTER PLAN THE MARCO ISLAND BIKE CLUB PRESENTED YEARS AGO
  CONCERNING ALL THE ADDITIONAL BIKE LANES ON SWALLOW AVE... SEEMS TO HAVE
  DISAPPEARED
- Bike lanes adjacent to major thoroughfares do not seem very safe. Cars travelling 50, 60, 70 or higher mph with just a few feet of you is very unsettling. It is frustrating that the multiuse trails are not consistent on roadways like Collier Blvd and Tamiami Trl.
- Biking would never replace driving for me. I bike for exercise and pleasure.... I drive out of necessity ...shopping ...appointments etc
- Well-lit, safe sidewalks are important to me. Better rules for e-bikes would help also, as they are sometimes ridden at dangerous speeds while I'm out walking my dog.
- The Chokoloskee causeway path could really use some help.
- BIG signs = Bikers on the roadway MUST obey the rules of the road, especially stop signs. BIG signs = bicycle paths are NOT for joggers. BIGGEST signs = Walk bikes over bridges = head car collision avoidance.
- Also important to connect sidewalks where gaps exist (3rd St between Central and 1st Ave South)
- Ban Electric Bicycles from all sidewalks. Require licensing for both E-Bikes and Operators.
- E-bikes riders are moving too fast to be on the sidewalk. Has decreased the time I spend walking each week.
- 18" wide Bike lanes within inches of the roads are not safe. There needs to be a barrier, or accommodation needs to be made on sidewalks (wider). Look up Scandinavian bike lane photos.
- Biking/walking is an excellent way to exercise and be outdoors. It would be great to have biking trails that would go all around Marco Island and out San Marco Rd the whole way to 41. Currently, biking is very dangerous around the Island as drivers do not pay attention.
- Look at transportation options for workers who live outside Naples. Traffic is a nightmare. Is there any opportunity for a west coast Brightline?
- More shared use sidewalks and bicycle education around use of bells
- "Collier between Fiddlers Creek to Marco needs a divided from traffic dedicated bike/pedestrian lane. The traffic speed is too fast. Not safe to share the small shoulder of the road with fast moving cars."
- Absolutely necessary to pursue and complete bike paths separated from roadways. The MPOs former plans for Greenways including the Bayshore Greenway would create a thriving community of bikers and walkers and boost the economy. The original Bayshore Greenway was shut down due to issues citied by the conservancy of SWFL as it would go through some wetland/sensitive areas. Rather than find low-cost solutions like culverts and bike/pedestrian bridges, the project was abandoned. Utilizing relic roadways (old Marco road, trash road, power line road) and routing a bike bath behind the massive communities that the county approved would have the potential to connect huge residential communities from Bayshore all the way to Isles of Capri. This would create a safe, beautiful, and efficient biking and walking path connecting residential areas to



commercial areas for all of East Naples. Rookery Bay Reserve is planning hydrology improvements in some of these areas. Happy to help.

- Nothing motorized allowed on sidewalks.
- Please make it clearer that bicycles MUST follow traffic laws, the same as cars. Too many ignore stop signs and traffic lights. So dangerous for cars. Car drivers will get blamed for any accident.
- "We need clear effective education about rules for the public.
- Pedestrians don't want to share the shared sidewalks and cars can't stay away from the thin white line on the road. So, we are to choose to possible get kill from a car or get verbally abuse and bully on social media sites by pedestrians."
- Too much traffic on Marco especially during the season. Hoping more bike lanes will reduce congestion and accidents.
- I won't ride my bike in bike lanes on a busy road. We need more shared path sidewalks that are away from car traffic. we also need more public transportation so people can take a bus or trolley up and down collier blvd.
- Need to get the word and plan out there.
- Important to link trails and paths. Need more off-road options. Roads even with bike lanes are dangerous.
- More and wider bike lanes to keep cyclists and power bikes off sidewalks.
- Would love more walking paths in Marco that are just for walking.
- Thanks for your efforts. Looking forward to more!
- Bike paths should be wider, so cyclists feel safer and stay off the sidewalks.
- The infrastructure in Collier County cannot afford any more building of houses and new communities. It has become very unsafe for runners, bikers and walkers It is unsafe driving here the roads are too overcrowded.
- Improving walkability / bike ability in Collier County is good for our health, our environment and our image.
- Separate bike and pedestrian paths would help as vehicle drivers do not seem aware of pedestrians crossing roads and endanger cyclists by driving too close to them.
- Bikes and pedestrians can share the sidewalk. People on bikes don't seem to follow road laws like stopping at stop signs, making hand signals, etc. They ride down the middle of the road (obviously under the speed limit), if they use a bike lane, they still don't obey the law.
- Did the prior survey that was sent out in 2023 by Collier County have any projects completed from the results? Will the results of this survey be used for any projects to be implemented?
- Try to design more dedicated trails connecting key locations. Also...add to #8...advantage would be less cars on the road.
- Many of the "snowbirds" are not everyday bike riders. They rent bikes, but don't know what they
  are doing. They ride on the road and not on sidewalks, this is not Hilton Head or similar. Marco is
  not really a "Beach Town" it is a city with a beach.
- Keep powered bikes and skateboards off the sidewalks so us walkers can walk in peace. We walk about five miles a day and someone is going to get killed by an electric bike or skateboard. They go past us doing 25 mph. It's ridiculous. We have bike lanes on Winterberry and San Marco but



hardly anyone uses them. The regular bikes can go in the bike lane to pass us walking and jump back on the sidewalk. That would be fine, but they don't think to do that. They want us to move for them.

- To continue the San Marco Rd bike path from Goodland to 41 would be ideal. Safer for cyclists and drivers!
- We need a separate slow vehicle infrastructure to get people out of cars.
- A pedestrian flyover walkover to connect the Greenway and Freedom Park over Golden Gate Parkway
- Add more dedicated bike & walking trails separate from streets.
- "I will not bike in the roadway due to safety concerns."
- I want to explain why I chose "poor" for #9. It's not that the roads are in bad shape. But the amount of roads and lanes has not kept up with the amount of growth and traffic, especially in GG Estates. Wilson Blvd needs to be extended to 951 right away, for instance. The VBilt extension needs to be fast tracked. I75 needs to be opened to the public at Everglades Blvd. And the timing of the lights all over Greater Naples needs to have a consultant brought in to get it right. The timing is absolutely frustrating.
- Thank you for working on this project.
- If bikes were a mode of transport there are still way too many cars on the road to make biking safe
- The Greenway Park and both Radio to Davis and Davis to Rattlesnake are nice but not connected. Livingston bike lane ends at GG Pkwy going South.
- Sidewalks are too narrow and well as bike lanes. Need to put space between cars and paths. Very dangerous on Marco
- Would love a 10' wide paved shared use path from the Marco bridge to US 41
- Ban all bikes from the road! They cause accidents and the bikers are rude!
- Keep bikes OFF the streets. They also need to follow all the rules if they're going to drive or ride
  their bike on the street. People on bikes seem to think they have the right of way all the time and
  don't even look or stop at red lights or use the crosswalk and that's what causes them to get hit.
- Sidewalks are important. I also feel we need to educate driver and also Bike rides to follow the rules. Example bike rides have lights on night.
- Collier, in general, is not a highly adaptable area for significant change with a master plan. Certain areas where cycling is more prevalent safer accommodations should be made.
- I like the wider paths that allow for biking and walking.
- Figure out how to have drivers pay attention and drive better. That's the biggest problem.
- Don't have any thoughts because I have not read it. You should put the link in the same post as the survey.
- Separate bike paths (when feasible) always welcomed over bike lanes.
- What has been done in Everglades City by taking one full lane for a bicycle path is not efficient
  whatsoever. We have so many tourists through our area that are driving below the posted speed
  limit because they are on vacation looking at everything and not knowing where they are going.
  The bicycle paths in Naples are not a full lane of traffic. They just redid all of the sidewalks in



Everglades City. They should be riding on that, not taking away a full lane for through traffic. It is very inconvenient for us that are trying to get somewhere and not on vacation. I'd like to see Naples take away a whole lane of traffic for a bike lane. And honestly i live down there and rarely if ever see anyone riding on those full lane bike paths, it's not worth it at all.

Needs to be more bike friendly.
