MPO MEETING CALENDAR UPDATE

The MPO Board's May 8, 2020 meeting has been canceled due to the lack of urgent items requiring action by the entire Board. The June 12, 2020 Board meeting will be held in the Board of County Commissioners Chambers, but we expect to conduct it as a virtual meeting to keep attendance within current guidelines. We are still working on the details with assistance from County IT and Communications

We are planning to hold the Citizens Advisory Committee (CAC) and Technical Advisory Committee) meetings on May 18th as virtual meetings; the same goes for the Bicycle and Pedestrian Advisory Committee (BPAC) meeting on May 19, 2020. In light of the current public health concerns, we are continuously monitoring changes in guidance for public meetings. Board and advisory committee members and the public will be notified of any changes that may result in the cancellation, rescheduling or conversion to an in-person meeting during the next few months.

LONG RANGE TRANSPORTATION PLAN (LRTP)



On 4/24/20, FDOT provided a map showing the results of another regional model run of the latest 2045 Socio-economic (SE) data with the 2023 E+C network based on SE changes submitted by Sarasota, Manatee, Charlotte, Lee County MPOs and Heartland RTPO. The resulting updated map of network deficiencies and any additional model run results will be posted on the MPO website. Check this link for

MPO staff has revised the UPWP in response to comments received from committee members, FDOT and FHWA. The MPO Chair has the authority to sign the UPWP and related documents in order to meet FDOT's May submittal deadline. The UPWP will be on the June agenda for the MPO Board to ratify along with other items approved and signed by the MPO Chair over the past few months while public meetings were suspended. The final, approved UPWP will be posted on the MPO website in mid-May. Watch for updates.
