## LONG RANGE TRANSPORTATION PLAN (LRTP)



Alternative Scenario Development and Modeling Continues: FDOT is partnering with MPOs by running the Planning Regional Model against a series of roadway network alternatives and 2045 forecasted growth characteristics. Beginning with the Existing + Committed Network, FDOT and the MPO moved on to test Alternative 1 which evaluated the adopted 2040 LRTP needs network. The MPO submitted Alternative 2 on May 15 to meet FDOT's deadline. Alternative 2 included additional capacity improvements to reduce the congestion forecasted by the model. The Citizens Advisory Committee and Technical Advisory Committee met [remotely] in May and June to review roadway deficiency plots and provide input on alternatives. Jacobs Engineering briefed the MPO Board at their June 12th meeting, received comments and answered questions. Jacobs is submitting Alternative 3 to FDOT for modeling on Tuesday, June 16th. Alternative 3 includes Cost Feasible Plan projects identified in the prior LRTP (2040) and Connected Automated Vehicles (CAVs) lanes on I-75.

Transit Development Plan- Tindale Oliver is the consultant. Josephine Medina is the MPO's Project Manager. The TDP will serve as the transit element of the 2045 LRTP. The project timeline and Public Participation Plan are on the website.

Transportation Disadvantaged Service Plan Minor Update— The TDSP identifies the types of paratransit service that will be provided for the community and the rates that will be assessed for that service. The 2020 TDSP Minor Update was approved by the Local Coordinating Board in its June 3rd meeting and ratified by the MPO Board on its June 12th meeting. The TDSP Minor Update will be submitted to the Florida Commission for the Transportation Disadvantaged (CTD) for final approval.

Transit Impact Analysis— Tindale Oliver is the consultant. Brandy Otero is the MPO's Project Manager. The project was requested by Collier County Public Transportation and Neighborhood Enhancement Division and funded by the MPO. It is intended to assess the impact of development on the transit network. The consultant is completing the draft report. Advisory Committee presentations will be scheduled for late Summer / early Fall. The project completion date has been extended until December 31, 2020. View the project scope at the link provided.

Park and Ride Study— Jacobs is the consultant. Josephine Medina is the MPO's Project Manager. The Park and Ride Study will identify prime locations, site plan considerations and planning level cost estimates that will aid the County and MPO Board in prioritizing future project expenditures. Transportation System Performance Report & Action Plan (TSPR) —Tindale Oliver is the consultant. Brandy Otero is the MPO's Project Manager. The TSPR will evaluate the root causes of congestion, establish baseline conditions and recommend actions the MPO can take to alleviate congestion. The Congestion Management Committee has been busy working on the project over the two years. At their last meeting they reviewed and commented on the draft Baseline Conditions report. The draft report can be viewed here. The project team is preparing for a virtual public meeting which will be scheduled during the month of July. The final report is expected to be approved by the MPO Board in September.

## Unified Planning Work Program FY21 - 22

The UPWP establishes the MPO's operating budget and planning priorities. The MPO's budget for staff and planning activities over the next two years is \$2,064,848. The new 2-year UPWP has been submitted to FDOT to meet their deadline. The MPO Board ratified the MPO Chair's action approving the UPWP at their June 12th meeting. #### Transportation Improvement Program FY21—25

The MPO Board adopted the new FY21-25 TIP at their meeting on June 12th. The adopted FY21-25 TIP can be viewed at: FY21-25 TIP

Total funding for this TIP is roughly \$488 million. This includes \$119 million in resurfacing, \$86 million on I-75 and \$33 million on US 41. Programming by Mode is approximately 1% for Planning, 2% for Bridges, 2% for Bike-Ped projects, 3% for Congestion Management, 4% Aviation, 8% Transit, 34% Maintenance and 46% Highways (capacity improvements).
