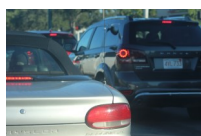
**Transit Development Plan**— Tindale Oliver is the consultant. Josephine Medina is the MPO's Project Manager. The TDP will serve as the transit element of the 2045 LRTP. The project timeline, draft Public Participation Plan and on-line survey are on the website.

**Park and Ride Study**— Jacobs is the consultant. Josephine Medina is the MPO's Project Manager. The Park and Ride Study will identify prime locations, site plan considerations and planning level cost estimates that will aid the County and MPO Board in prioritizing future project expenditures.

**Transit Impact Analysis**— Tindale Oliver is the consultant. Brandy Otero is the MPO's Project Manager. The project was requested by Collier County Public Transportation and Neighborhood Enhancement Division and funded by the MPO. It is intended to assess the impact of development on the transit network. The completion date of 4/30/2020 is likely to be extended. View the project scope at the link provided.

**Transportation System Performance Report & Action Plan (TSPR)**—Tindale Oliver is the consultant. Brandy Otero is the MPO's Project Manager. This study implements an important element of the 2017 Congestion Management Process. The TSPR will evaluate the root causes of congestion, establish baseline conditions and recommend actions the MPO can take to alleviate congestion. The information will feed into the 2045 LRTP. The anticipated completion date is June 2020.

The UPWP establishes the MPO's operating budget and planning priorities. Brandy Otero, the MPO's Principal Planner, is developing the new draft UPWP for submittal to advisory committees in February and to the Board in March for preliminary review, adoption in May.
