GORDON RIVER GREENWAY TRAFFIC COUNTER

A Continuous Bicycle and Pedestrian Traffic Counter has been installed and certified at the Gordon River Greenway. It will be counting non-motorized traffic at this location. The collected data helps FDOT TDA toward their goal of creating an Average Annual Daily Traffic (AADT) for non-motorized facilities.

AIRPORT ROAD WIDENING PROJECT

This project will widen the Airport Road corridor into a six-lane divided urban arterial roadway by adding an additional 11-foot travel lane in each direction and on-street bicycle facilities. Plans call for a 22-foot raised median, curb, and gutter, reconstruction of sidewalks along both sides of the roadway, a closed drainage system, street lighting, and minor traffic signal improvements.
