COLLIER MPO HAS PLANS FOR YOU...

Collier MPO Plans Progress Toward Final Adoption. Now's the Time to Get Involved!

Over the past several months, the Collier MPO has been refining key components of the **Long Range Transportation Plan** (LRTP), and now, two related plans: the **Bicycle and Pedestrian Master Plan** (BPMP) and the **Safety Action Plan** (SAP) are reaching the finish line. This is your opportunity to add your voice to the conversation! Both plans will be presented for **review and comment** at these meetings:

-  **August 19** | Bicycle & Pedestrian Advisory Committee (BPAC)
-  **August 25** | Technical and Citizens Advisory Committees (TAC/CAC)
-  **September 12** | Collier MPO Board (MPO)

These 3 meetings are an opportunity for community members to learn about the plans, ask questions, and share their thoughts. After this round of feedback, the 2 plans will be **revisited by the committees in September** and brought to the **Collier MPO Board for adoption on October 10, 2025**.

The **LRTP** will be presented to **TAC/CAC August 25**, followed by the **MPO Board on September 12**. The final plan will go to the **MPO Board for adoption on December 11, 2025**.

The **Transit Development Plan** (TDP) is expected to be presented to **TAC/CAC in August**, followed by the **MPO Board in September** and **Collier County Board of County Commissioners also in September**.

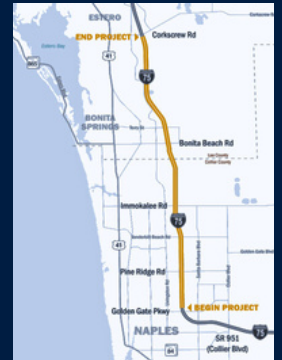

The Florida Department of Transportation (FDOT) is conducting a Project Development and Environment (PD&E) Study for an 18.5 mile segment of I-75 from north of Golden Gate Parkway in Collier County to south of Corkscrew Road in Lee County.


The purpose of this project is to increase capacity and improve traffic operations, accommodate future traffic demand, and enhance safety along the mainline of I-75 and associated interchanges between Golden Gate Parkway and Corkscrew Road.
