COLLIER MPO'S QUADRENNIAL FEDERAL REVIEW

Every four years, the Federal Highway and Transit Administrations conduct a certification review of the local transportation planning process. The purpose of the review is to evaluate Collier MPO's compliance with Federal transportation rules and regulations.

The review site visit will be conducted at Collier MPO on July 23, 2024, from 8:30 a.m. to 5 p.m. Virtual observation is offered to the public. Register to observe the Collier MPO TMA Certification Review Site Visit

The site review will include a Public Meeting on July 23, 2024, from 6 p.m. to 7 p.m. This will be an opportunity for the public to provide comments regarding the Collier MPO transportation planning process.

The public meeting will be held at Collier MPO. Virtual observation and/or participation is offered for the public meeting. Public participation is encouraged.
