### I-75 AT PINE RIDGE ROAD (EXIT 107) INTERCHANGE IMPROVEMENTS PROJECT

I-75 at Pine Ridge Road interchange improvements include the design of a diverging diamond interchange (DDI), which will significantly reduce delay on Pine Ridge Road and reduce the number of conflict points to improve overall safety for all users. The DDI will also accommodate future traffic volume growth. FDOT is holding public workshops to share details about the project and provide the public with an opportunity to comment:
