COLLIER MPO HAS A CORNUCOPIA OF PLANS IN DEVELOPMENT!

Collier MPO's Long Range Transportation Plan (LRTP) is a multimodal plan that includes highway and transit infrastructure improvements and considers environmental impact, economic development, mobility, safety, security, and quality of life. The 2050 LRTP update is currently in production and is projected for completion and adoption in December 2025.

<u>The LRTP</u> is the master plan and guiding document for the future of transportation in Collier County, including the cities of Naples, Marco Island, and Everglades City. It guides project prioritization for the <u>Transportation</u> <u>Improvement Program</u> and incorporates MPO's adopted <u>Congestion Management Process</u>, as well as the <u>Bicycle</u> <u>and Pedestrian Master Plan</u>, <u>Safety Action Plan</u>, and <u>Transit Development Plan</u>, all currently in development.


ONLINE SURVEY FOR COLLIER COUNTY TRANSIT DEVELOPMENT PLAN
