
County Interactive Growth Model (CIGM)


- Assist Collier MPO with Socioeconomic Allocations in the County Interactive Growth Model (CIGM) for the 2045 LRTP
- Metro Forecasting Models (MFM)
- Predict and allocate growth according to:
 - zoning entitlements
 - local land use policies
 - water and sewer utilities
 - roadway capacity
 - parcel size
 - environmental conditions
- LRTP Scope includes testing land use "scenarios" to model transportation needs generated by local land use policies and zoning entitlements and whether alternative land use or network scenarios for new growth and redevelopment areas would result in greater efficiencies and lower costs

Keeping Up with Your MPO

Looking Ahead to the 2045 LRTP



As we begin the process of updating the 2040 Long Range Transportation Plan (LRTP) to the new horizon year of 2045, there are a number of "givens" that must be addressed, Population projections are one of them. Collier MPO uses the medium range projection developed by the Bureau of Economio and Business Research (BEBR). BEBR is projecting a very clight decrease in the rate of growth for Collier County, compared to the 2040 LRTP. None-the-less, the population is projected to grow from rough-

ly 388,000 in 2017 to 520,000 (in round numbers) by 2045. FDOT's Revenue Projections for Collier County are another 'given't the MPO' must address in the LRTP's Cost Feasible Plan. Available State and Federal Funds for Capacity Projects (excluding Transportation Regional Incentive Program and Transportation Management Area Small Urban) total \$778.36 million about double the amount projected for the 2040 LRTP.

"Statewide Trends Affecting Transportation," published by FDOT's Forecasting and Trends Office in 2017, shows growth steadily increasing for the state as a whole. Trends indicate a steadily increasing number of licensed drivers and registered vehicles, along with increased Daily Vehicle Miles Traveled (VMT) and increased congestion on the State Highway System.

curve in congestion, but not as extreme as that experienced in more heavily populated MPOs. Statewide, the number of fatalities and serious injuries is trending up along with population growth and increasing VMT. Transit ridership is decreasing statewide, and in Collier County as well.
