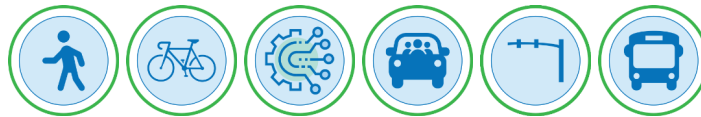

## Congestion Management Process



### What is Congestion Management?

A Congestion Management Process (CMP) is a detailed 8-step process that an urban area follows to improve the performance of its transportation system by reducing the negative impacts of traffic congestion. A CMP is developed to improve traffic flow and safety conditions. It seeks to accomplish this by using a combination of strategies that can reduce travel demand, improve traffic operations, or provide options other than driving alone during times when roadways tend to be more congested.

### When will this be finished?

The MPO is currently updating the CMP analysis and existing conditions known as the Transportation System Performance (TSP) Report. An Action Plan Report with identified congestion reduction strategies is also being finalized. The MPO Board is scheduled to take action on these reports at their September 11, 2020 Meeting.

### How are these strategies funded?

The Collier MPO receives federal transportation revenues that are prioritized on an annual basis. The MPO allocates 40% of these revenues over a five-year period for CMP projects. Implementation of the strategies is coordinated with FDOT, Collier County, and City agencies.

### Is there a draft report I can review?

### Will there be a presentation during the Virtual Meeting?

MPO Staff and the consultant team have prepared a presentation that can be viewed on the MPO website and will be aired on Collier County TV (Comcast Channel 97).

### Why should I participate?

During the virtual meeting, participants will receive a presentation on the analysis and proposed congestion reduction strategies. An opportunity to ask questions about the analysis and provide input on the proposed congestion strategies is available during this outreach period and on the MPO's website.
